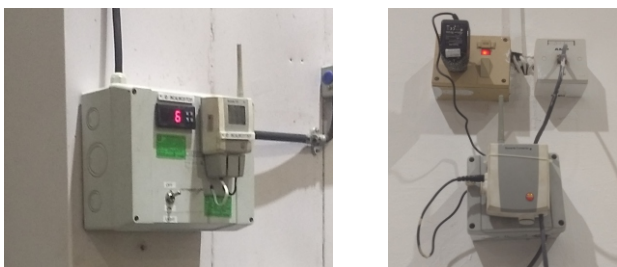

**Measurement Challenge faced, prior to testo Saveris system implementation:**

Previously we used to monitor data manually using hygrometer on daily basis, due to which we were not able to take measurements on weekends, holidays etc. Another issue that we witnessed was that there was no continuous monitoring since the respective person used to take readings only on the predefined timings in morning and the evening. Also, there were chances of human error where the person could by mistake taking wrong reading or the deviations go unnoticed and everything seems within limits.

**Brief on actual application area where the system is installed:**

We have storage rooms/warehouse facilities to store the tablets and medicines in a mandatory temperature of less than 25°C. The Saveris system is installed for these cool rooms where regulatory samples are stored in controlled climate.



**Does testo Saveris fulfil your statutory requirements and compliances?**

As per the statutory requirements the area temperature to be monitored must be below 25°C. This standard is set as per the government guidelines & testo Saveris system enables us to monitor and adhere to the set standards.
