Measurement Challenge faced, prior to testo Saveris system implementation:

Prior to testo Saveris system, we were doing manual monitoring of the parameters. But there were many issues that we faced. First and foremost was the unavailability of continuous monitoring of the data, that too without any proper alert system so any deviation from the standards was difficult to detect. Also, no data recording facility was possible & we had to rely on the methods which in some cases were prone to manual errors, and since there was no automated system hence data storage and retrieval was a difficult task. We even faced problems with data integration and report generation. But with testo Saveris system almost all the issues have been taken care of and we are able to monitor the necessary parameters efficiently.

Brief on actual application area where the system is installed:

Testo Saveris system is installed in the warehouse and production block of our company for the monitoring and recording of temperature and humidity of chemical storage areas. As per our standards the required temperature should not be more than 25°C and humidity should not be more than 65%. testo Saveris probes are installed at the desired locations and the parameters are monitored accordingly.
